Privacy Policy

This website is operated by JIFox Education Pty Ltd ABN 82 617 078 832, who trade as Revision Village (“Revision Village”, “we”, “us”, “our”) under the domain name www.revisionvillage.com (“the website”).

We are committed to protecting your online privacy and safety. This Privacy Policy explains what information we collect when you use Revision Village, how the information will be used, and how you can control the collection, correction and/or deletion of information. This Privacy Policy applies only to information you provide us through the Revision Village website. Capitalized terms that are not defined in this Privacy Policy have the meaning given to them in our Terms of Use.

What We Collect

Personal Information

When you register to use the Revision Village website, you provide us information about yourself, such as your name, username and e-mail address. You may also provide us with financial payment information, geolocation information, Unique Device ID (UDID), all subject to the applicable privacy settings, if a purchase is made.

Log File Information

When you use the Service, our servers automatically record certain log file information. These server logs may include information such as your web request, Internet Protocol (“IP”) address, browser type, referring / exit pages and URLs, number of clicks and how you interact with the Service, domain names, landing pages, pages viewed, and other such information. Clear Gifs Information. When you use the Service, we may employ clear gifs (also known as web beacons), which are used to track the usage patterns of our users anonymously. In addition, we may also use clear gifs in HTML-based emails sent to our users to track which emails are opened by recipients. The information is used to enable more accurate reporting, improve the effectiveness of our marketing, and make Revision Village better for our users. Revision Village uses third party analytics services like Google Analytics to help understand use of the Service. These third party analytics services collect the information sent by your usage of the Service. Revision Village stores passwords in a secure database. This password information is encrypted and Revision Village cannot access/ view these details.

Your Rights

As users of the Revision Village website, you have the following rights about your data that you provide to Revision Village during the user process:

- A right to erase: You have full authority for all of your data to be completely erased from our servers. To take this action, please email our support team at support@revisionvillage.com and the request will be processed within 48 hrs.

How We Use Your Information

We use the personal information you submit to operate, maintain, and provide to you the features and functionality of the Service. What We Do With Your Information

Personally Identifiable Information

Revision Village will not rent or sell your personally identifiable information to others. Revision Village may share your personally identifiable information with third parties for the purpose of providing the Service to you. If we do this, such third parties’ use of your information will be bound by this Privacy Policy. We may store personal information in locations outside the direct control of Revision Village (for instance, on servers or databases co-located with hosting providers). We may also transfer or assign your information in the course of corporate divestitures, mergers, or dissolution. Revision Village may disclose your personal information if required to do so by law or subpoena or if we believe that such action is necessary to (a) conform to the law, comply with legal process served on us or our affiliates, or investigate, prevent, or take action regarding suspected or actual illegal activities; (b) to enforce our Terms & Conditions, take precautions against liability, to investigate and defend ourselves against any third-party claims or allegations, to assist government enforcement agencies, or to protect the security or integrity of our site; and (c) to exercise or protect the rights, property, or personal safety of Revision Village, our Users or others. We may share non-personally identifiable

information (such as anonymous usage data, referring/exit pages and URLs, platform types, number of clicks, etc.) with interested third parties to help them understand the usage patterns of Revision Village.

How We Protect Your Information

Revision Village cares about the integrity and security of your personal information. We keep your personally identifiable information in encrypted form on a secured server behind a firewall. We also use automated and social measures to enhance security, such as analyzing account behavior for fraudulent or otherwise anomalous behavior, may limit use of site features in response to possible signs of abuse, may remove inappropriate content or links to illegal content, and may suspend or disable accounts for violations of our Terms of Use or Privacy Policy. Although we allow you to set privacy options that limit access to your information, please be aware that no security measures are perfect or impenetrable. We cannot control the actions of other users with whom you share your information. We cannot guarantee that only authorized persons will view your information. We cannot ensure that information you share on Service will not become publicly available. We are not responsible for third party circumvention of any privacy settings or security measures on Service.
